Any company that has only group long-term care policy and certificate forms approved for sale in Virginia or has issued a policy to an association (i.e., AARP) or to a group policyholder not located in Virginia may not appear on this list. Also, there may be other companies that offer long-term care insurance in this state. If you have questions on how the purchase of a qualified long-term care policy will impact the taxes you pay, you should consult with your tax advisor.
