Refer to the column entitled "Plans" to determine which of the Medigap standardized plans are currently marketed by a particular company. Other information to be considered is also noted in this column. The following may be helpful in assessing information that may be found in the "Plans" column:

- **High deductible Medigap Plan F.** This policy generally has a higher deductible and will cost you more "out-of-pocket" money before reimbursement may be made for certain services. The cost for this policy is generally lower than regular Medigap policies because of the high deductible feature.
