Please accept this letter, filed electronically, as Virginia Natural Gas, Inc.'s ("VNG") notification to the State Corporation Commission ("Commission") concerning the conditions precedent for issuance of a certificate of public convenience and necessity ("CPCN") prescribed by the Commission in its Preliminary Order on Application issued in this proceeding on June 26, 2020 ("Preliminary Order").

On December 6, 2019, VNG, filed an application ("Application") and supporting materials with the Commission for approval and certification of natural gas facilities pursuant to Virginia Code §§ 56-265.1 and 56-265.2.1. VNG's Application also sought approval to implement Rate Schedules HP-TRFT, HP-FT, HP-LFT, and HP-IT and Terms and Conditions for Pipeline Transportation Service. The Company sought approval and certification in order to provide new service to an independent power producer, C4GT, LLC ("C4GT"), for an electric generation facility to be located in Charles City County, Virginia, to provide incremental transportation capacity to existing customers, including Columbia Gas of Virginia ("CVA") and Virginia Power Services Energy ("VPSE"), and to help maintain reliable service in the area.

The Preliminary Order, among other things, directed the Company to file on or before December 31, 2020, confirmation that "(i) C4GT's financial close is scheduled, certain, and imminent; (ii) C4GT has approved expenditures by the Company on the C4GT components of

the Project; and (iii) all relevant aspects of the agreements between C4GT and VNG remain in full force and effect.”<sup>1</sup>

The Company presents this letter to inform the Commission that the conditions precedent related to C4GT will not be satisfied on or before December 31, 2020.

The Company further notes that it intends to file a revised version of its Application within 90 days in order to seek certification and approval of natural gas facilities required to provide incremental transportation capacity to existing customers, including CVA and VPSE, and to maintain reliable service in the area. VNG respectfully requests the Commission hold the existing docket open for receipt of this revised filing. Doing so will promote judicial economy as interested parties will remain participants in the case and be served all subsequent case materials.
