On November 5, 2021, Virginia Electric and Power Company (the “Company”) filed with the State Corporation Commission (“Commission”) an Application for Approval and Certification of Electric Transmission Facilities: Virginia Facilities, approval of Rider OSW, and Request for Limited Waiver (“Application”).

Contemporaneous with the filing of the Application, and consistent with the limited request for waiver therein of certain requirements under Rules 60 and 90 of the Rules Governing Utility Rate Applications and Annual Informational Filings of Investor-Owned Electric Utilities (“Rate Case Rules”), the Company has submitted UNDER SEAL one hard copy of key documentation supporting the projected and actual costs set forth in the Application in this proceeding, as well as three electronic copies of these materials on compact discs, which are responsive to the requirements of Filing Schedule 46.
