

## File a Registered Agent Resignation for a Foreign Business Entity in the Clerk's Information System

Every Virginia and foreign business entity authorized to transact business in Virginia must continuously maintain a Virginia-located registered agent and registered office. This how-to guide will walk you through filing a Statement of Resignation of Registered Agent online in the new Clerk's Information System (CIS) <u>https://cis.scc.virginia.gov/</u>.
