ADMINISTRATIVE ORDER NO. 11888

ORDER SUSPENDING THE REQUIREMENT OF FILING CERTAIN
RATES, PROSPECTIVE LOSS COSTS, OR SUPPLEMENTARY RATE
INFORMATION FOR USE IN WRITING COMMERCIAL LIABILITY
INSURANCE, PURSUANT TO THE PROVISIONS OF SECTION 38.2-
1903 OF THE CODE OF VIRGINIA.

WHEREAS, Pursuant to the provisions of Section 38.2-1903 of the Code of Virginia, the State Corporation Commission previously exempted, by Administrative Order No. 11867 dated March 16, 2010, certain rates from the filing requirements of Chapter 19 of Title 38.2 because such rates cannot practicably be filed prior to use; and,

WHEREAS, The Commissioner of Insurance continues to find that rates, prospective loss costs, and supplementary rate information for certain types and classes of liability insurance, as defined in Sections 38.2-117 and 118 of the Code of Virginia, cannot practicably be filed prior to use and should continue to be exempted from the filing requirements of Chapter 19 of Title 38.2;

IT IS THEREFORE, ORDERED:

- (1) That Administrative Order No. 11867 is hereby withdrawn;
- (2) That the requirement of filing certain rates, prospective loss costs, or supplementary rate information is suspended for those types and classifications of commercial liability insurance that are specifically referenced in this order;
- (3) That, should any insurer elect to file rates or supplementary rate information for the classes of liability insurance exempted by this order, such rates or supplementary rate information shall be deemed to be filed manual rates for the purposes of that insurer, notwithstanding this exemption;
- (4) That the exemptions provided by this order shall not apply to any classification of liability insurance which is subsequently found to be non-competitive and subject to the prior-filing requirements of Section 38.2-1912 of the Code of Virginia; and,
- (5) That the rates, prospective loss costs, and supplementary rate information affected by this order and hereafter used by insurers shall not be excessive, inadequate, or unfairly discriminatory; and the Commission hereby reserves the right, either upon its own motion or upon complaint, to make such examination or investigation with respect thereto as it may deem advisable or necessary in order to determine whether any rates, prospective loss costs, and supplementary rate information affected by such suspension may be, or may become, excessive, inadequate, or unfairly discriminatory.
