General Information:

<u>Definitions – as used in this list:</u>

- * **EPO (Exclusive Provider Organization) Product** A plan covering health care services provided only through a specified network of providers, except in emergency situations.
- * HMO (Health Maintenance Organization) Product A product offered by a company licensed as an HMO covering health care services provided only through a specified network of providers, except in emergency situations.
- * **POS (Point-of-Service) Product** A product offered by a company licensed as an HMO covering health care services provided through a network of participating providers and *out-of-network providers*. Typically, a POS requires the policyholder to pay higher costs when he seeks care from an *out-of-network provider*.
- * **PPO (Preferred Provider Organization) Product** A product offered by an insurance company covering health care services provided through a network of participating providers and *out-of-network providers*. Typically, a PPO requires the policyholder to pay higher costs when he seeks care from an *out-of-network provider*.
- ** **SHOP or Small Business Exchange –** Small Business Health Options Program, also known as the SHOP Marketplace or Small Business Exchange. For information about the SHOP for Virginia, please refer to Small Business Employers | Virginia's Insurance Marketplace.
