ORDER FOR NOTICE AND HEARING

On April 30, 2024, Kentucky Utilities Company d/b/a Old Dominion Power Company ("KU/ODP" or "Company") filed an application ("Application") with the State Corporation Commission ("Commission") requesting authority to adjust its electric base rates pursuant to Chapter 10 of Title 56 of the Code of Virginia ("Code")¹ and the Commission's Rules Governing Utility Rate Applications and Annual Informational Filings of Investor-Owned Electric Utilities.²

KU/ODP seeks an increase in base rates to produce an increase in revenues in the amount of approximately \$9.4 million, which is a 12.7% increase in its total operating revenues, including fuel.³ The Company indicates that this rate request is based on a 10.50% return on common equity.⁴ Additionally, KU/ODP proposes to increase its basic service charge for residential service.⁵ Specifically, for residential customers, the Company proposes a basic

service charge of \$15.00 per month, which is a \$3.00 increase to the Company's current \$12.00 basic service charge for residential service.⁶

If KU/ODP's proposed rate increase is approved, the impact on customer bills would depend on the customer's rate schedule and usage. According to the Company, the proposed increase would raise the monthly bill of a residential customer using 1,000 kilowatt hours per month by \$19.46, from \$139.03 to \$158.49, an increase of 14%.

The Application also includes proposed revisions to the Company's tariffs, including new time of day rates for residential and general service customers and a new outdoor sports lighting rate schedule. KU/ODP also proposes to increase: (i) the monthly meter pulse charge from \$21.00 to \$22.00; (ii) the disconnect/reconnect charge from \$37.00 to \$53.00; and (iii) the meter test charge from \$79.00 to \$81.00.9 The Company proposes changes to the various unauthorized reconnection charges and text changes to reflect that all replacement meters will be AMI meters. 10

KU/ODP includes in its Application a request for the Commission to extend the authority granted in Case No. PUR-2020-00110.¹¹ The Company states that while it received authorization from the Commission to replace certain wood structures with galvanized steel

structures on three separate 161 kV transmission circuits within existing right-of-way ("Rebuild Project"), the work has not been completed due to permitting issues. ¹² Accordingly, KU/ODP is requesting an extension of time, through June 30, 2026, to complete and energize the Dorchester – Pocket North line component of the Rebuild Project. ¹³

The Company also requests the Commission issue a declaratory order that approval under Code § 56-89 is not necessary to sell five minor vacant properties owned by the Company, or alternatively, grant authority to dispose of these properties at some future point in time.¹⁴

KU/ODP further requests to be relieved of an annual reporting requirement arising from the transfer of ownership approved by the Commission in Case No. PUE-2010-00060.¹⁵ The Company states that the reporting requirement is no longer necessary.¹⁶

Lastly, on May 1, 2024, KU/ODP filed a Motion for Entry of a Protective Ruling ("Motion").

NOW THE COMMISSION, upon consideration of this matter, is of the opinion and finds that KU/ODP should provide public notice of its Application; a hearing should be scheduled for the purpose of receiving testimony and evidence on the Application; a procedural schedule should be established to allow interested persons to file comments on the Company's Application or to participate in this proceeding as a respondent; and the Staff of the Commission ("Staff")

should be directed to investigate the Application and file testimony and exhibits containing its findings and recommendations thereon. We further find that KU/ODP's proposed changes in rates, tolls, charges, rules, and regulations should be suspended until the Commission's final order in this proceeding. Finally, we find that a Hearing Examiner should be assigned to conduct all further proceedings in this matter on behalf of the Commission, including ruling on the Motion and filing a final report containing the Hearing Examiner's findings and recommendations.

To promote administrative efficiency and timely service of filings upon participants, the Commission will, among other things, direct the electronic filing of testimony and pleadings unless they contain confidential information, and require electronic service on parties to this proceeding.

Accordingly, IT IS ORDERED THAT:

- (1) This matter is docketed and assigned Case No. PUR-2024-00052.
- (2) The Company's proposed changes in rates, tolls, charges, rules, and regulations are suspended pursuant to Code § 56-238 until the Commission's final order in this proceeding.
- (3) All pleadings in this matter should be submitted electronically to the extent authorized by 5 VAC 5-20-150, *Copies and format*, of the Commission's Rules of Practice and Procedure ("Rules of Practice"). Confidential and Extraordinarily Sensitive Information shall not be submitted electronically and should comply with 5 VAC 5-20-170, *Confidential information*, of the Rules of Practice. Any person seeking to hand deliver and physically file or submit any pleading or other document shall contact the Clerk's Office Document Control Center at (804) 371-9838 to arrange the delivery.

- (4) Pursuant to 5 VAC 5-20-140, *Filing and service*, of the Rules of Practice, the Commission directs that service on parties and Staff in this matter shall be accomplished by electronic means. On April 30, 2024, Kentucky Utilities Company d/b/a Old Dominion Power Company ("KU/ODP" or "Company") filed an application ("Application") with the State Corporation Commission ("Commission") requesting authority to adjust its electric base rates pursuant to Chapter 10 of Title 56 of the Code of

The Company also requests the Commission issue a declaratory order that approval under Code § 56-89 is not necessary to sell five minor vacant properties owned by the

Company, or alternatively, grant authority to dispose of these properties at some future point in time.

KU/ODP further requests to be relieved of an annual reporting requirement arising from the transfer of ownership approved by the Commission in Case No. PUE-2010-00060. The Company states that the reporting requirement is no longer necessary.

The Commission has suspended implementation of the proposed revisions to the Company's rates, tolls, and charges until a final order is issued in this proceeding.

On November 13, 2024, at 10 a.m. or at the conclusion of the public witness portion of the hearing, whichever is later, in the Commission's second floor courtroom located in the Tyler Building, 1300 East Main Street, Richmond, Virginia 23219, a Hearing Examiner appointed by the Commission will convene a hearing to receive testimony and evidence offered by the Company, any respondents, and the Commission's Staff on the Company's Application.
