

Instructions to Form SCC55.1-1211 – Appointment of Resident Agent by Nonresident Property Owner

This form is to be completed by a "nonresident property owner," which is defined as any nonresident individual or group of individuals who owns and leases residential real property located in Virginia. This form *cannot be filed by business entities* that own or lease residential real property located in Virginia.

Pursuant to § 55.1-1211 of the Code of Virginia:

- Every nonresident property owner is required to appoint and to continuously maintain an agent who (i) if such agent is an individual, is a resident of Virginia, or if such agent is a corporation, limited liability company, partnership, or other entity, is authorized to transact business in Virginia and (ii) maintains a business office in Virginia.
- Every lease executed by or on behalf of a nonresident property owner regarding any residential real property shall specifically designate an agent and provide the agent's office address for the purpose of service of any process, notice, order, or demand required or permitted by law to be served upon the nonresident property owner.
- No nonresident property owner shall maintain an action in the courts of the Commonwealth of Virginia concerning property for which an agent designation is required until such designation has been filed.
