The application must be in the English language, typewritten or printed in black, legible and reproducible. The document must be presented on uniformly white, opaque paper, free of visible watermarks and background logos.

The corporation's name <u>must</u> be distinguishable upon the records of the Commission in order for it to register its name with the Commission. See § 13.1-632 of the Code of Virginia for a stock corporation and § 13.1-831 of the Code for a nonstock corporation. To check the availability of a corporate name, visit <u>https://cis.scc.virginia.gov</u> or contact the Clerk's Office at (804) 371-9733 or toll-free, 1-866-722-2551.

If the corporation is a stock corporation and its name does not contain the word "corporation," "incorporated," "company" or "limited"; or the abbreviation "corp.," "inc.," "co." or "ltd.," the corporation may only register a name that <u>adds</u> one of these words or abbreviations to its true name. See §§ 13.1-632 and 13.1-762 of the Code of Virginia for a stock corporation and §§ 13.1-831 and 13.1-924 of the Code for a nonstock corporation.

The application must include a brief description of the nature of the business in which the corporation is engaged.

The application must be signed in the name of the corporation by the chairman or any vice-chairman of the board of directors, the president, or any other of its officers authorized to act on behalf of the corporation.

IMPORTANT: This application, for registration or renewal of registration, must be **accompanied by a certificate** setting forth that the foreign corporation is **in good standing**, or a document of similar import, from the state or country of incorporation, executed by the official who has custody of the records pertaining to corporations.

A **registration** is effective for one year after the date on which the application is filed. A **renewal** is effective for one year after the date on which the registration would have expired.

A registration terminates when the foreign corporation obtains a certificate of authority to transact business in Virginia.

A corporation may **release** a registered name by filing a notice of release of a registered name with the Commission. The notice must be signed on behalf of the corporation by a person who is authorized to sign an application (see above) and must be accompanied by a check in the amount of \$10.00 made payable to State Corporation Commission.

Do not include personally identifiable information, such as a Social Security number, in a business entity document submitted to the Office of the Clerk for filing with the Commission.
