

OPEN ENROLLMENT FOR INDIVIDUAL HEALTH INSURANCE

November 1, 2021 - January 15, 2022

IF YOU ARE NOT ENROLLED IN A PLAN BY JANUARY 15, 2022, PAST THAT DEADLINE YOU MUST QUALIFY FOR A SPECIAL ENROLLMENT PERIOD TO ENROLL

- If you have Health Insurance Marketplace (Marketplace) coverage in 2021, login to your account at healthcare.gov/login to review plan changes and new options available.
- Compare plan cost and benefits to find the best options for you. Even if you are notified of automatic reenrollment, you can choose a different plan at any time during open enrollment.
- Check with insurers or view at healthcare.gov which doctors, hospitals, and prescription drugs are covered under the available plans.
- If you are not eligible for financial assistance through the Marketplace, you may be able to find lower cost off-Marketplace ACA-compliant health care plan options through finder.healthcare.gov.
- Once enrolled, you must pay your first binder payment on time for coverage to begin. Payment is due to the insurance company – not the Marketplace.
- To receive a Medicaid eligibility determination, you must update your Marketplace account. If you are found eligible for Medicaid, you should end your Marketplace coverage; otherwise, you may be re-enrolled into your Marketplace plan, and will not get financial assistance.
